## TRI-STATE'S GOT TALENT OFFICIAL CONTEST RULES

- 1. Tri-State's Got Talent is the audition process for a spot in the 2020 Really Big Show, a variety show hosted at the Old National Events Plaza in Evansville, Indiana to benefit The Arc of Evansville.
- Talented individuals or groups who wish to participate must perform a live audition on November 16, 2019 between 2:00pm -3:30pm at the Eastland Mall Food Court located at 800 N Green River Rd, Evansville, IN 47715.
- 3. Registration will begin at 1:30pm, and auditions will be accepted in the order of arrival and registration.
- 4. Walk-up registrations are accepted until 3:30pm with time permitting.
- 5. Auditions must be 90 seconds or less.
- 6. Each act may audition only one time. If a contestant is a member of a group act, he or she may also audition as a solo act; however, the contestant will be limited to one group audition and one solo audition.
- 7. We want to see your performance of singing, dancing, plate spinning, juggling or a unique trick you and a friend have dreamed up to entertain others! Please remember to keep your talent "family friendly" as The Really Big Show is a production for all ages. The Arc of Evansville reserves the right to refuse any act deemed inappropriate for The Really Big Show.
- 8. Auditions will be judged by a panel of judges from The Really Big Show Talent Committee. Monetary or in-kind items of any sort will not be accepted by The Really Big Show Talent Committee as contest bribery. Acts will be judged on appropriateness for The Really Big Show, uniqueness, quality, and time needed to perform the act.
- 9. The winner of Tri-State's Got Talent will be announced at the conclusion of the auditions on November 16<sup>th</sup> and on the home page of www.arcofevansville.org the week following the event.
- 10. All participating contestants must be available to attend The Really Big Show rehearsal and the performance on Saturday, February 8, 2020. Rehearsal will be from approximately 10 a.m. until 3:00 p.m. All acts will also need to be available from 6:00 p.m. until approximately 9:00 p.m. for the show.
- 11. Performances during The Really Big Show should not exceed 3 minutes in length.
- 12. All acts must provide their own music, equipment, costumes and props if needed.
- 13. By entering this contest, a participant consents to the use, without additional compensation, of his or her name and likeness or voice for promotion and advertising purposes in connection with this contest. Winners may be required to furnish an affidavit of eligibility and release.
- 14. The Arc of Evansville reserves the right to change these rules at any time.
